Enclosed is an application for food concession space for the International Finals Youth Rodeo to be held July 12 - 17, 2020. There will be 11 performances with competition beginning on Sunday, July 12 at 8PM and concluding Friday, July 17 with the Finals performance at 7:30PM. There will be two performances a day, Monday through Friday, at 9AM and 7:30PM.

Set up for concessionaires will be on Saturday, July 11 (if needed) and OPEN for business by Sunday July 12 at 11AM., then working hours through Friday night for the final performance. IFYR performances are typically two hours or so long, however most of our over 800-plus contestants and their families stay on Expo Center grounds all week (so with the right incentive, you can have potential customers at any point). We also have a contestant/public dance on Expo Center grounds Monday through Thursday nights from 10PM to 1AM and the practice pen and jackpot arenas on grounds re hopping with contestants deep into the night as well.

Rental space shall be in the amount of 20% of daily gross sales paid to the IFYR. Ice is sold on grounds shall you need to purchase it for your business. All spaces will be assigned by the IFYR in conjunction with the Heart of Oklahoma Expo and the Shawnee Civic & Cultural Development Authority.

If you should decide to apply, complete all items on the application form and return to us along with a \$100 deposit by March 16, 2020. If your application is not accepted, your deposit will be returned.
