

Stalling Information -We Do Not Allow Tack Stalls To Be Purchased-

On grounds inside & outside stalls are limited. Stall Assignment are made by date entered online 1ST to Sign Up 1st to be Assigned Basis. Stalls must be purchased by the person utilizing the stall, if you purchase it, your horse needs to be in it. Don't purchase for brother or sister, they purchase their own as they enter. If you purchase a stall it is then considered your responsibility as far as IFYR is concerned.

Before Check-In:

- Have copies of all horse papers including Coggins Test, health papers and IFYR horse registration. You must have these papers to check in your horse. Papers will be kept @ Stalling Office until contestant and horse check out after the rodeo.
- The stalling office is OPEN 24 hours a day for check-in beginning 8 AM Friday, July 6th through 12 PM Sunday, July 8th - If your horse isn't checked in by Noon Sunday you will not be riding at IFYR 2018 – NO EXCEPTIONS, It causes delays for our Stalling Committee so **ALL HORSES MUST BE CHECKED IN BY SUNDAY JULY 8TH @ NOON – NO EXCEPTIONS – EVEN OFF GROUNDS HORSES MUST COEM BE CHECKED IN BY NOON ON SUNDAY – EVERY HORSE RIDING IN IFYR MUST BE CHECKED IN BY NOON ON SUNDAY!**
- Trailers will be parked by an attendant in a specific location. Trailers will be towed if illegally parked. Your cooperation will be appreciated if you are asked to move your trailer. You CAN NOT park your truck/trailer during check in and block the drive lanes- Each trailer is given 30 minutes to have your business handled and the trailer moved-
- ONLY STUDS can be placed in STUD STALLS, which are separate from other horses. Horses will be allowed ONLY in the stalling areas and the arena areas. Horses will not be allowed in any of the following areas: RV Park, Parking Lots, Trade Show Area, Pedestrian Areas, streets or sidewalks south of the Grandstand.

Procedures After You Have Checked Your Horses In:

- Stalls will be monitored 24 hours per day during the entire rodeo. You cannot trade stalls, if you didn't purchase it, stay out of it unless IFYR moves you there.
- Trailers will not be allowed to be unloaded (tack, feed, etc.) in the alleyway between barns during check-in. Do Not Park and Leave Vehicles.... 30 minutes is max time allowed then security will be called-
- After checking horse in, any stalling changes can only be made from 8 A.M. to 5 P.M. only by the Stalling Chairman.
- If a horse is found in the wrong stall, it will be removed by the Stalling Committee. If you didn't purchase it online or have it in writing it isn't legally yours so stay out of it unless IFYR puts you there.
- NO 3 or 4 Wheelers, Bikes, Hover Boards or Segways allowed on grounds.
- DO NOT wash horses or tack in the barn or in the grass areas outside barns use WASH RACKS ONLY.
